## **COPA PROMOTES GA WITH NATIONAL LAWMAKERS**

Representatives from various sectors of Canada's aviation industry gathered for the first time at the Air Transport Association of Canada (ATAC) annual Aviation Day on the Hill, an opportunity to promote aviation and discuss issues facing the industry with Ottawa's lawmakers. COPA was a key contributor and assisted with the organizing of this event.

Throughout the evening, the discussion centered on the pilot shortage and the various ways the different sectors of the industry are coping with the challenges on this front. COPA has long maintained and advocated for General Aviation's role as the front door of the aviation industry. In that context, COPA representatives discussed the continuing threats to community aerodromes across Canada from other levels of government, utility companies and land developers. The federal government's sole role in regulating aeronautics and aerodromes has been repeatedly upheld at the highest levels and we continue to rely on that protection to ensure the survival of our aerodromes. Without places to train and to entice a new generation of pilots, Canada's aviation industry would come to a grinding halt.



Many MPs and a few Senators from all political parties attended and each one shared their

commitment to ensuring a strong and viable aviation industry for all sectors. The event provided the opportunity to maintain existing relationships, build new ones, and even sign up some new COPA members. We look forward to seeing this initiative grow and participating in subsequent Aviation Days on the Hill in years to come.

## AOPA AUSTRALIA FIGHTS TO PROTECT FUTURE OF YARRAWONGA AIRPORT

AOPA Australia Executive Director Benjamin Morgan seeks partnership with Moira Shire Council to secure the future of Yarrawonga Airport

The future for Yarrawonga Airport on the New South Wales and Victorian border remains in doubt with Moira Shire Council working towards a public Expression of Interest (EOI) for the sale of the airport which includes 112 hectares of land, a sealed 1,200-meter runway with pilot activated lighting, a recently constructed terminal building and fuel facilities.

Following a public consultation process in October of 2018, the Moira Shire Council announced that it would proceed to an EOI with an intent to sell-off the airport, with the process commencing in June of 2019. Council's proposal to privatize Yarrawonga Airport has been met with strong industry opposition, with local



aircraft owners and pilots concerned that a sale would destroy the local aviation community through the introduction of ever-increasing unregulated fees and charges.

AOPA Australia has contacted Moira Shire Council to express its concerns for the future of the airport under privatized ownership, calling on Council to meet to discuss achievable alternatives through a partnership with industry.

"We are looking forward to meeting with the Moira Shire Council and its airport management to gain a better understanding of the challenges and difficulties it faces. Our goal is to establish a partnership with council to develop an achievable strategy that would eliminate any need to privatize the airport asset," AOPA Australia Executive Director Benjamin Morgan.

"AOPA Australia welcomes a strong working partnership with all councils, in seeking to find ways to help make airport ownership and operation more efficient and sustainable. I am certain that the interests and goals of the aviation community and council are aligned, we simply need to get around the table and start the discussion."

"Yarrawonga Airport is invaluable to the local community and it would be a tragedy to see the asset thrust into the hands of property developers who's focus would be profit – not community."

"A sale of the airport would without question negatively impact on the local aviation business community, resulting in closures and job-losses. It is important that we meet with Council to explore achievable alternatives that can provide a platform for growth and success, whilst remaining under local government community ownership," he said. AOPA Australia is currently awaiting a meeting confirmation from Moira Shire Council Economic Development Officer Karen Abberfield, which is anticipated before the close of May 2019.

#### **REAL PILOT STORY: POWERLESS OVER PARIS**

The Aircraft Owners and Pilots Association (AOPA) Air Safety Institute (ASI) has released Powerless Over Paris, the latest video installment in its popular Real Pilot Story series.

In Powerless Over Paris, Dr. Peter Edenhoffer relives the moment his airplane suffered a complete electrical failure in heavy instrument meteorological conditions (IMC) at night. As he speaks about the flight, Edenhoffer shares his thoughts and actions, including a fleeting moment of doubt about his chances for surviving the dilemma. However, with a little luck and creativity he and the air



traffic controllers on duty finally established contact. But, would Edenhoffer be able to find the airport and land? Hear the story first hand from the pilot and air traffic controllers involved.

AOPA Air Safety Institute executive director Richard McSpadden praised the pilot and controllers for their resourcefulness in tackling a difficult situation. "The pilot's focus on maintaining positive aircraft control in hard IMC while troubleshooting a critical electrical failure is a testament to the impact quality training and pilot proficiency have on safety. In addition, the controllers' ability to think on their feet outside the norm reflects a collaborative intensity that permeates the aviation community and makes us safer," said McSpadden.

In 2018, air traffic controllers Charlie Porter, Phil Enis, Hugh Hunton, and Bryan Beck received the prestigious President's Award from the National Air Traffic Controllers Association (NATCA) for their heroic efforts in bringing pilot Edenhoffer to a safe landing.
